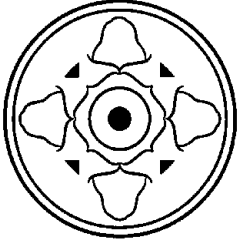
- ii. A total of 67 shareholders have voted successfully using the remote e-voting facility.
