quidity in the system. In the month of January 2019, system had tighter liquidity situations owing to the outflow due to Goods and Services Tax. Further, RBI had indicated that it is committed to provide sufficient liquidity in the markets through OMOs (open market operation purchase of government securities)," the Survey said.

The External Financial Linkages Index improved by 31.5 points Q-o-Q to 67.4. According to the Survey, 25 per cent of the respondents expect the foreign exchange reserves to decrease, with 46.4 per cent expecting it to increase, while nearly 29 per cent expect it to remain the same.

In terms of net capital inflows, 60.7 per cent of the respondents expect that the investment by FIIs (foreign institutional investors) will increase. Since economic growth is quite impressive and other macro-economic fundamentals are also showing improvement, the Survey

observed that the FIIs inflows will show an upward trend in this quarter.

In terms of nominal exchange rate, approximately 68 per cent of the respondents expect the exchange rate to appreciate and some 21 per cent of the respondents expect the exchange rate to depreciate. During the last one month, there was not much of volatility in the rupee/US dollar movement.

The Economic Activity Index nudged up 2.2 points to 64.7. This value of economic activity index is supported by high optimism regarding the growth in GDP as well as non-food bank credit pick up.

The Survey indicates 50 per cent of the respondents expect GDP growth to increase in the current quarter, with nearly 29 per cent expecting otherwise while the remaining 21.4 per cent of the respondents believe that the GDP growth will remain the same.

"Deceleration in crude oil

prices, and the slower pace of monetary policy tightening across the globe are expected to help in India's economic growth. Majority of the respondents concur with the bright growth prospects for the country," the Survey said.
