# SC permits reopening of dance bars in Maharashtra, with caveats

New Delhi, January 17

Stating that there can be "regulations" but not "total prohibition", the Supreme Court on Thursday paved the way for the reopening of dance bars in Maharashtra by setting aside some provisions of a 2016 law imposing restrictions on their licensing and functioning.

An apex court Bench headed by Justice AK Sikri permitted them to be located within a kilometre of religious places and educational institutions. The court allowed tips to performers, but disallowed showering of currency on them.

### No CCTV cameras

The apex court quashed some provisions of the Maharashtra Prohibition of Obscene Dance in Hotels, Restaurants and Bar Rooms and Protection of Dignity of Women (working therein) Act, 2016, such as mandatory installation of CCTV cameras in the dance bars, saying it violated privacy.

The Bench, however, upheld the restriction on the timing of operation of dance bars from 6 pm to 11.30 pm. "From 2005 till date, not a single person has been given licence (for dance bars). There can be regulations but it cannot amount to total prohibition," the Bench said while pronouncing the judgment.

## **Location of bars**

The apex court said the provision that dance bars be located 1 km from religious places and educational institutions is "unconstitutional" and also quashed the provision that there must be a partition between bar rooms and the dance floor. In August last year, the court reserved its verdict on the pleas of hotel and restaurant owners challenging the Act.

Earlier, the petitioners told the Bench that the State government had tried to circumvent a previous order of the apex court with the 2016 law. Hotel and restaurant owners argued that the State government adopted an attitude that it would not permit dance bars irrespective of the orders passed by the apex court.

On January 11, 2017, the apex court directed the Maharashtra government to expeditiously decide the pending applications for licences to open dance bars under the old rules and the directions issued by the court from time to time.
